DBE Program Complaint in Federal Court calls for the "ending of the DBE program once and for all." The 40-year-old Disadvantage Business Enterprise program that enhances contracts to women and minority-owned firms on federally funded transportation projects is being challenged in a Federal Court in Kentucky. The Office of Minority & Women's Business Enterprise and Washington State Department of Transportation are holding a listening session with the local DBE community on January 18. Register here. Cybersecurity Certification: CMMC 2.0 proposed rule was published on December 26. The 200page document outlines the multi-phase approach to ensuring contractors and subcontractors implement required security protections as a condition of award. Comments are open until February 26. The final rule is expected to be enacted in Fall 2024 with a fullcompliance deadline of 2026. Contractors waiting to see what will be required are encouraged to lean in now and understand what will be required and the steps they must take to achieve compliance and stay competitive in the marketplace. Project Labor Agreements: New guidance for agencies was published on December 18<sup>th</sup> for implementing the 2022 Executive Order requiring Project Labor Agreements on federally funded projects valued at over \$35 million. Amongst the guidance are details on the market research analysis agencies must complete for the project or IDIQ contract to be exempted. Read the fact sheet <u>here</u> and guidance <u>here</u>.

State Contract Clause: A new antidiscrimination clause will be added to all state contracts for public works, goods, and services starting January 1. The clause will need to flow down to subcontractors and be shared with labor organizations with which your firm has collective bargaining or other agreements. Learn more at this <u>link</u>.
